### SALUKI SUCCESS INITIATIVE STUDENT CONTRACT

I, \_\_\_\_\_ agree to participate in the Saluki Success Initiative (EXP2), during my first two consecutive semesters as a student at Southern Illinois University Carbondale. My responsibilities include:

- I must enroll only in courses approved by my academic advisor for the duration of my participation in this program. Changes (i.e., drops or adds) in my course selection (class schedule) require **prior** approval from my academic advisor.
- Mandatory Semester Kick Off Meeting during the first week of the semester.
- Mandatory progress meetings each week with my academic advisor, recruitment and retention coordinator, tutor, academic coach, mentor, and/or other engagement activities approved by Exploratory Student Advisement.
- Monthly meetings with my academic advisor, recruitment and retention coordinator, mentor, tutor, academic coach, events, and workshops required by Exploratory Student Advisement.
- Complete the UNIV 101A course in the Fall Semester.
- Regular attendance is required in all of my classes except for absences excused by my instructor.
- Satisfactory completion of all course work on time.
- Violations of the SIU Student Conduct Code may result in disciplinary action and dismissal from the program and/or University.

I agree that failing to comply with **any** of the above may result in my administrative withdrawal from SIU at any time during the semester, with no financial credit/refund. Furthermore, I understand that I will be held responsible for Housing prorated charges and contract cancellation fees assessed as a result of my being administratively withdrawn from the University.

#### SATISFACTORY PROGRESS

I understand that to remain in good academic standing, I must maintain an institutional (SIU) grade point average (GPA) of 2.0 (out of 4.0). If I receive a 0.0 GPA during my first semester in 12 or more credit hours at SIU, I will be academically suspended from the University. If I receive a 0.0 GPA during my first semester in less than 12 credit hours at SIU, without having officially withdrawn from the semester, I will be administratively withdrawn from the University. If I receive an institutional GPA greater than 0.0, but less than 2.0, I will be placed on academic probation. If, while on academic probation, I earn less than a 2.0 GPA, I will be suspended and exit from SIU. **Finally, if I have a cumulative institutional GPA of less than 2.0, I understand there may be financial aid implications.** I understand that to be admitted into the Saluki Success Initiative (EXP2) and to be provisionally accepted to SIU, I must sign and return this contract. Failure to return this contract **by July 1** will result in denial of my application for the Fall 2023 semester.
